### DEFINITIONS

**ADMINISTRATOR, WARRANTOR, WE, US, and OUR** - Ascent Administration Services, LLC, 1550 E. McKellips Road, Suite 117, Mesa, AZ 85203, (866) 660-7003.

**COVERED VEHICLE** - The Vehicle identified on the Application Page to which the protection products have been applied as indicated on the Application Page.

**LIMITED WARRANTY** - The Limited Warranty that has been provided to You, for no consideration, with the purchase of the Windshield Glass magnifier protection product(s).

**LIMITED WARRANTY TERM** - The Limited Warranty Term which begins on the Product Purchase Date on the Application Page.

**YOU and YOUR** - The **Covered Vehicle** Owner identified on the Application Page and purchaser of the protection product(s) as indicated on the Application Page.

### TERM OF THIS LIMITED WARRANTY

This Limited Warranty begins on the Product Purchase Date identified on the Application Page and expires upon the passing of the Limited Warranty Term indicated on the Application Page.

### WHAT THIS LIMITED WARRANTY COVERS

The following section describes the types of damage that the protection product is designed to help prevent and what We will do in the event the protection product fails to perform as specified. Such service will be performed with reasonable promptness and quality. The Warrantor has no obligation toward reimbursement of transportation or inconvenience costs during the time of repair. There is no deductible for service under this Limited Warranty.

- **Windshield Glass Modifier:** We hereby guarantee the applied protection product will help prevent damage to the windshield caused by a propelled object. Should the treated windshield become chipped or cracked, the **Warrantor** will repair the chip or crack completely free of charge, to the fullest extent possible, subject to the **WHAT THIS LIMITED WARRANTY DOES NOT COVER** section.  
If it is determined by the licensed repair technician that the damaged windshield must be replaced because such repairs will not allow it to function safely, We will replace the windshield and cover the recalibration of the windshield up to a limit of liability of ten thousand dollars (\$10,000).

Only one (1) replacement windshield benefit is provided during the Limited Warranty Term.

### WHAT THIS LIMITED WARRANTY DOES NOT COVER

We will not provide coverage for any of the following: (1) Cracks or other damage caused by any peril other than a propelled object. This exclusion includes, but is not limited to stress cracks and damages caused by vehicle theft, vandalism, fire, hail or other weather conditions, factory defects, war or warlike acts including acts of terrorism, insurrection, rebellion, revolution, nuclear radiation or radioactive contamination; (2) Windshield replacement necessitated by Your failure to take reasonable steps to mitigate Your damages including but not limited to Your failure to timely repair; (3) Windshield replacement in any case wherein You failed to notify Us of the loss within fifteen (15) days of the date that You discover the damage.

### TRANSFER & CANCELLATION

Covered Vehicle Owner's Right to Transfer: The original Covered Vehicle owner will have the right to transfer this Limited Warranty to the first subsequent owner of the Covered Vehicle. To continue the Limited Warranty coverage, the first subsequent owner must e-mail Us at [transfers@ascentadmin.com](mailto:transfers@ascentadmin.com) to request a transfer within thirty (30) days from the date of transfer/purchase of the Covered Vehicle.

The protection product(s) that You have purchased, as indicated on the Application Page, has been applied to Your Covered Vehicle and cannot be removed; therefore, **THIS LIMITED WARRANTY IS NON-CANCELABLE BY YOU AND THE PURCHASE PRICE OF THE PRODUCT IS NON-REFUNDABLE.**

### HOW TO MAKE A CLAIM

The damage once incurred, may greatly worsen unless repairs are promptly made. In order to reasonably minimize any additional damage that might occur, a claim must be filed online at [www.ascentadmin.com](http://www.ascentadmin.com), or by calling (866) 660-7003 within fifteen (15) days from the onset of damage. **Photos of the damage may be required for the processing of the claim.**

- You must call Us at (866) 660-7003 and receive a claim authorization number **PRIOR** to initiating any repairs. Our claims hours are 6:30am- 4:30pm PST Monday through Friday. To reasonably minimize further damage which might occur, a claim must be filed with Us within fifteen (15) days from the date of either the appearance of damage covered by this Limited Warranty or the time when damage could have been discovered upon reasonable observation or inspection.
- We will give You authorization to have the repair made when the claim is approved. Any repairs made on claims prior to receiving authorization will be denied.
- For reimbursement, after all services are completed, You must provide Us a copy of the following: (1) this Limited Warranty; (2) the invoice(s) or receipt(s) evidencing the applicable service; (3) the completed claim form with the claim number; and (4) any other records reasonably requested by Us. If You are unable to use the online or email options, You must contact (866) 660-7003 for submission instructions.
