# VEHICLE SERVICE COVERAGE

## ENGINE & WATER PUMP

This contract includes coverage for the following components: pistons, piston rings, piston pins, crankshaft and main bearings, connecting rods and rod bearings, camshaft and bearings, timing chain and gears, intake and exhaust valves, valve springs, oil pump, push rods, rocker arms, hydraulic lifters, rocker arm shafts, and water pump. Coverage also applies to all internally lubricated parts of the turbocharger/supercharger (factory-installed only), as well as the engine block, cylinder heads, and turbocharger/supercharger housing if they are damaged by these parts. Routine replacement parts, seals, and gaskets are excluded unless necessary for the replacement of a covered component.

## TRANSMISSION/TRANSAXLE

This contract covers all internally lubricated parts of manual or automatic transmissions, including the oil pump, drums, planetaries, sun gear and shell, shafts, bearings, side gears, carrier pinion gear, ring gear, shift rail, forks, synchronizers, and torque converter. Coverage also applies to the transmission/transaxle case if damaged due to the failure of an internally lubricated covered part. Damage caused by the failure of related parts or components, such as friction parts (e.g., clutches), levers, controls, linkage, cables, radiators, coolers, rubber mounts, external oil lines, viscous couplings, drive axles, and internal or external electrical components related to the engine or transmission, is not covered. Seals and gaskets are covered only if needed for the replacement of a covered part.

## TRANSFER CASE

This contract covers all internally lubricated parts of the 4x4 transfer case, including coverage for the transfer case itself if damaged due to the failure of an internally lubricated covered part. Damage caused by the failure of related components, such as friction parts (e.g., clutches), levers, controls, linkage, cables, radiators, coolers, rubber mounts, external oil lines, viscous couplings, drive axles, and internal or external electrical components related to the transfer case, is not covered. Seals and gaskets are covered only if necessary for the replacement of a covered part.
